- d) Arranging skater assessments and competitions, and establishing and granting awards and distinctions;

The special provisions of the Corporation are deleted in their entirety and replaced with the following:

(a) The Corporation shall be authorized to establish the following classes of Membership:

(i) Ordinary Members:

Ordinary Members shall be entitled to receive notice of and attend all meetings of the members of the Corporation and each Ordinary Member shall have one (1) vote at each such meeting;

(ii) Parent Members:

Parent Members shall be entitled to receive notice of and attend all meetings of the members of the Corporation and each Parent Member shall have one (1) vote at each such meeting;

(iii) Honourary Members:

Honourary Members shall be entitled to receive notice of and attend all meetings of the members of the Corporation and each Honourary Member shall have one (1) vote at each such meeting;

(iv) Associate Members:

Associate Members shall not be entitled to receive notice of or attend any meetings of the members of the Corporation and no Associate Member shall have a vote at each such meeting;

(b) Commercial purposes, if any, included in the articles are intended only to advance or support one or more of the non-profit purposes of the Corporation. No part of a Corporation's profits or of its property or accretions to the value

of the property may be distributed, directly or indirectly, to a member, a director or an officer of the Corporation except in furtherance of its activities or as otherwise permitted by the Ontario Not-for-profit Corporations Act, S.O. 2010, c.15 (the "Act").

(c) Upon the dissolution of the Corporation and after satisfying the interests of its creditors in all its debts, obligations and liabilities, its remaining property shall be distributed as follows:

(i) If the Corporation is a public benefit corporation as defined by the Act, its remaining property shall be distributed to another public benefit corporation with similar purposes to its own, a Canadian body corporate that is a registered charity under the Income Tax Act, R.S.C., 1985, c. 1 (5th Supp.) with similar purposes to its own, the Crown in right of Ontario, the Crown in right of Canada, an agent of either of those Crowns or a municipality in Canada; or

(ii) If the Corporation is not a public benefit corporation as defined by the Act, its remaining property shall be distributed to a not-for-profit corporation with similar purposes to its own or to one (1) or more figure skating clubs in Mississauga.
